## **Order**

- **S.O.** ----- (E). In exercise of the powers conferred by section 16 of the Bureau of Indian Standards Act, 2016 (11 of 2016), the Central Government is of the opinion that it is necessary or expedient so to do in the public interest, after consulting the Bureau hereby makes the following order, namely:-
  - 1. Short title, commencement and application. (1) This order may be called the Steel and Steel Products (Quality Control) Order, 2019.
    - (2) It shall come into force on the date specified in the Official Gazette.
    - (3) It shall apply to steel and steel products specified in column (3) of the Table 1, but nothing herein shall apply to such products meant for export.
  - 2. Conformity to standards.- (a) Every product specified in column (3) of the Table 1 shall conform to the corresponding Indian Standards specified in column (2) of the said Table 1.
  - **3.** Compulsory use of Standard Mark.- Every Steel and Steel products specified in this order shall bear the Standard Mark under a license from the Bureau.
    - The sub-standard or defective steel and steel products, which do not conform to the specified standard, shall be disposed off as scrap as per the scheme of testing and inspection of Bureau of Indian Standard.
  - **4.** Certification and enforcement authority.- The Bureau shall be the certifying and enforcing authority in respect of the steel and steel products, goods and articles specified in this order.
  - **5.** Penalty for Contravention. Any person who contravenes any of the provisions of this Order shall be punishable under Section 29 of the Act.
  - Date of effect of amendment or revision in Indian Standards. When any amendment or revision is made by the Bureau to any of the Indian Standards specified in the Table 1, such amendment or revision shall apply to this order with effect from the date notified by the Bureau in this behalf.
