Auction Notice

Subject:- Disposal of old and condemned car regarding.

In super-session of M/o Steel's Auction Notice of even No. dated 1st August, 2011 (which stands cancelled) the undersigned is directed to say that it is proposed to dispose of one Ambassador Car being Registration Number DL 9CA 4971 manufacturing year 1998.

2. Accordingly, sealed quotations are invited for the disposal of said vehicle on the terms and conditions mentioned below. In case you are interested in purchasing the above mentioned vehicle, you may submit your highest quotation in the **enclosed Performa**. The quotations addressed to the undersigned in a sealed cover should reach this Ministry **latest by 11.00 A.M. on 9th September, 2011**. The quotations received in time will be opened at 11.00 A.M. i.e. immediately after closing of tendering time. The quotations should be dropped in the Tender Box kept at Reception of Gate No.1, Udyog Bhawan, New Delhi. The cover should be prominently super scribed with the words "QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE". **The vehicle will be available for inspection between 2.30 PM to 4.00 P.M. on the 8th September, 2011.**

3. The quotations received in time will be opened in Room No.74, Udyog Bhawan, New Delhi. The bidders or their representative (not more than one) may be present, if they so desire, at the time of opening of quotation.


4. The sale will be governed by the following conditions:

- i) The bidder is required to pay Earnest Money of Rs.5000/- payable by means of Demand Draft drawn in favour of **Pay and Accounts Officer, Ministry of Steel, New Delhi. However the person who had already participated in the previous bid or intended to participate and prepared Bank Draft during 1st August, 2011 to 16th August, 2011 for the bid in favour of P&AO M/o Steel such DD shall also be accepted for this bid/tender.**
- ii) Quotations received **without demand draft towards Earnest Money will not be considered and shall not be accepted.**
- iii) The successful bidder will be required to deposit the rest bid amount by means of cash/demand draft drawn in favour of Pay and Accounts Officer,

Ministry of Steel, New Delhi **within three working days** of the acceptance of the bid.

- iv) If it is found that the amount quoted by the successful bidder (highest bidder) is less than the reserve price fixed by the Airport Authority of India, the bid will be treated as cancel.
- v) The Earnest Money of the successful bidder will be released only after the deposit of sale proceeds. Earnest Money will be forfeited if he fails to honour the bid. However if the successful bidder so agrees, it may be adjusted in the final payment of the vehicle.
- vi) The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status viz. Ration Card/Voter Identity Card/Passport in case of individual and Registration Certificate in case of firms etc. this formality will have to be completed within 5 days from the date of issue of letter to him in this regard.
- vii) The sold vehicle will be removed by the successful bidder **within five working days of depositing the money at their own expenses after that a penalty of Rs. 500/- per day will be charged.**
- viii) The vehicle will be disposed of on as is where is basis and no guarantee for its worthiness or quality will be given by this Ministry.
- ix) The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. The Ministry will not be responsible for any lapse on his part in this regard.
- x) The bidders will not be allowed to withdraw their bids, failing which their Earnest Money will be forfeited.
- xi) The competent Authority in Ministry of Steel reserves the right to accept or reject any/all of the quotations without assigning any reason therefore.
