In case you are interested in purchasing the above mentioned vehicle, you may submit your highest quotation in the enclosed Performa. The quotations addressed to the undersigned in a sealed cover should reach this Ministry **latest by 11.00 A.M. on 1st May, 2013**. The quotations received in time will be opened at 11.30 A.M. on the same day. The quotations should be dropped in the Tender Box kept at Reception of Gate No.1, Udyog Bhawan, New Delhi. The cover should be prominently super scribed with the words "QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE". **The vehicle will be available for inspection between 2.30 PM to 4.00 P.M. on 29th April, 2013 & 30th April, 2013 (only two days) after seeking an appointment with the section officer (Admn. Genl) on Telephone No. 23062537.**

3. The quotations received in time will be opened in Room No.74, Udyog Bhawan, New Delhi. The bidders or their representative (not more than one) may be present, if they so desire, at the time of opening of quotation.

4. The sale will be governed by the following conditions:

- i) The bidder is required to pay Earnest Money of Rs.5000/- payable by means of Demand Draft drawn in favour of **Pay and Accounts Officer, Ministry of Steel, New Delhi.**
- ii) Quotations received without demand draft towards Earnest Money will not be considered and shall not be accepted.
- iii) The successful bidder will be required to deposit the bid amount by means of cash/demand draft drawn in favour of Pay and Accounts Officer, Ministry of Steel, New Delhi **within two working days** of the acceptance of the bid.
- iv) *If it is found that the amount quoted by the successful bidder (highest bidder) is less than the reserve price fixed by the Airport Authority of India, the bid may be treated as cancel.*

- v) The Earnest Money of the successful bidder will be released only after the deposit of sale proceedings. Earnest Money will be forfeited if he fails to honour the bid.
- vi) The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status viz. Ration Card/Voter Identity Card/Passport in case of individual and Registration Certificate in case of firms etc.
