**2. The auction will take place in front of Gate No. 5 Udyog Bhawan, New Delhi at 3.30 PM on 30 / 11 / 2012.**

3. The items available for bid will be available for inspection at Room No. 74 Udyog Bhawan, New Delhi by 3.00 PM during 26 / 11 / 2012 to 29 / 11 / 2012.

4. The bid will be governed by the following terms and conditions:-

- (a) The goods shall be disposed of on **"as is where is basis"**
- (b) **The Bidder should deposit a sum of Rs. 5000/- (Five Thousand Only in cash with the Cashier of M/o Steel, New Delhi towards bid security. The proof of residence/registration and registration letter of the firm may also be submitted along with the bid amount and acceptance of the terms and conditions in writing as mentioned in the tender notice by 3.00 PM on / 12/2012. The bid amount and other document submitted after 3.00 PM will not be considered.**
- (c) The successful bidder shall have to deposit the rest of the bid amount (Full bid amount – Rs. 5000/-) in the form of DD or cash with the DDO Steel within 2 working day.
- (d) The goods, after depositing the full amount, are to be lifted, at own cost, within the time frame agreed by the Ministry (only on Govt. Holiday).
- (e) The bidder have to take the entire article and do not allow to leave parts of article viz. seat of chair/sofa/parts of blinds/ wood piece etc.
- (f) The disposal of the material shall normally be awarded to the highest bidder fulfilling all the terms/conditions as aforesaid or may be decided by the Ministry during the course of the commencement and completion of the process.
- (g) If the selected firm does not show inclination to lift the store and in any way refused to honors the offer. The bid security deposited shall be forfeited and other actions like banning of business dealing with the Ministry and resale of goods in question at the risk/cost of the defaulters shall be taken without any further intimation; and
