I. COMPANY PROFILE

KIOCL Limited was incorporated under the Indian Companies Act, 1956 with the objective to mine low grade Magnetite Iron Ore & beneficiate the same for further use. The Company is currently operating 3.5 MTPA Iron Oxide Pellet Plant and has Blast Furnance Unit to manufacture 2.16 lakh tonne per annum Pig Iron at Mangalore, Karnataka. KIOCL is a schedule - 'A' Mini Ratna CPSE in the Mineral and Metals sector under the administrative control of Ministry of Steel.

The authorized and paid up capital of the Company was Rs. 675 crores and Rs. 634.51 crores respectively as on March 31, 2018.

Its Registered and Corporate office are at Bangalore, Karnataka.

The shareholding of the Government of India in the company is 99%.

II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Commercial) is a member of the Board of Directors and reports to Chairman and MD. He is responsible for all commercial activities of the Company comprising materials management, marketing and shipment. He is also responsible for implementation of the decisions of the Board relating to above mentioned areas of work.
