#### Subject: <u>Third party audit of proactive disclosure of Public Authority Ministry of Steel, New Delhi u/s 4</u> of the RTI Act-2005-2023-24.

Sir,

The Right to Information Act, 2005 allowed the citizen to access information under the control of public authorities. It has multiple dimensions. The most commonly known and widely utilized, is the filing of requests by the information seekers and the subsequent process of first and second appeals. This is the demand side of the transparency law.

The other dimension, which is the law's supply-side is a scheme of voluntary disclosure of information by public authorities (PAs) through a variety of means, principal among which is the disclosure through their websites.

Section 4 of RTI Act 2005 imposes obligations on Public Authorities to disclose certain information Suo-moto. For ensuring compliance of disclosure under section 4 of act, DOPT issued guidelines vide OM No. 1/6/2011-IR dated15.04.2013, which inter-alia provided that each Ministry/Department shall get its proactive disclosure package audited by third party every year.

Accordingly, National Institute of Secondary Steel Technology, (NISST) Mandi Gobindgarh, Punjab, was nominated to conduct third party transparency audit of Ministry of Steel, New Delhi.

As per self-appraisal report & Suo-motu disclosure of information by Ministry of Steel, New Delhiat their Website under RTI Act, the Summary Report is enclosed at Annexure -1.

We appreciate the sincere efforts of Ministry of Steel, New Delhias Public Authority for sharing required information on website to maintain the transparency. It has been observed during the Audit that the information relates to few areas has to be shared on website with more clarity like;

1. Consultancy committee of key stake holders for advice on suo-motu disclosure.

2. Committee of PIOs/FAAs with rich experience in RTI to identify frequently sought information under RTI.

3. Updation required with regard to citizen charter, details of applications received & disposed and details of appeals received and orders issued.

NISST would like to share positive feedback that in future all the required information/url/links may be posted on website to meet the Transparency Audit Matrix.
