Order

S.O. (E). - In exercise of the powers conferred by section 16 of the Bureau of Indian Standards Act, 2016 (11 of 2016), the Central Government being of the opinion that it is necessary or expedient so to do in the public interest and after consulting the Bureau, hereby makes the following order, namely:-

1. Short title, commencement and application. –

- (i) This order may be called the Steel and Steel Products (Quality Control) Fourth Order, 2019.
- (ii) It shall come into force on the date as decided by Ministry of Steel.
- (iii) It shall apply to steel and steel products specified in column (3) of Table 1 except steel and steel products for export which conform to any other specification required by a foreign buyer.

2. Conformity to standards and essential requirements.- (a) Every steel and steel product specified in column (3) of Table 1 shall conform to the corresponding Indian standards specified in column (2) of the said Table with effect from the dates specified in column (5) thereof.

(b) Tin plate and Tin Free Steel as input material for the products mentioned in the Column (2) of Table 2 shall be bearing Standard Mark under a license issued by BIS as per Scheme – I of Schedule – II of the BIS Standards (Conformity Assessment) Regulations, 2018. Additionally, the products mentioned in the Column (2) of Table 2 shall be accompanied with the test certificate carrying BIS license number of input material.

3. Compulsory use of Standard Mark.- Every steel and steel products specified in column (3) of Table 1 shall bear the Standard Mark under a licence from the Bureau as per Scheme–I of Schedule–II of the Bureau of Indian Standards (Conformity Assessment) Regulations, 2018.

4. Certification and enforcement authority.- The Bureau shall be the certifying and enforcing authority in respect of the steel and steel products, goods and articles specified in this order.

5. Penalty for contravention. - Any person who contravenes any of the provisions of this order shall be punishable under the provisions of the Bureau of Indian Standards Act, 2016.

6. Date of effect of amendment or revision in Indian Standards. - This order shall apply to any amendment or revision made by the Bureau to any of the Indian Standards specified in Table 1 with effect from the date notified by the Bureau in this behalf.
