6. Profile of the Organization:

- iii. To provide various industrial services and testing facilities required for producing quality products.
- iv. To extend consultancy services to industries in term of solving technological problems, improving efficiency and reducing pollution levels to meet societal expectation for sustainable growth.
- v. To promote research & development and design work in frontier areas for providing update technology to this sector either independently or in collaboration with institutes of repute.
- vi. To prepare data bank about the secondary sector and thus organize documentation and information retrieval services to the industry.
- vii. To provide the platform for interaction between industry and educational as well as research institutions.

Besides above, NISST guides the Ministry of Steel from time to time regarding measures to be taken to improve the secondary steel sector performance and its competitiveness.

7. Job Description and Responsibilities

The Director as the Principal Executive officer shall be responsible for the proper administration of the affairs and funds of the NISST and shall report to the Board headed by the Chairperson, NISST. He/She shall be vested with such executive and administrative powers of the NISST as may be necessary or incidental for the purpose.

8. Essential Educational qualification

Bachelor Degree in Metallurgical / Mechanical Engineering or Material Science from a recognized University.

A Master of Business Administration or Master in Metallurgical/Material Science/Mechanical Engineering will be an added advantage.

9. Eligibility Conditions:

- i. Serving Officers from Public Sector Undertakings/Organizations (steel/ other metal industry) with minimum 3 years' service in the pay scale of E-6 and above.
- ii. Candidates from Private Sector should have atleast 20(Twenty) years' experience at Executive level in Metallurgical industry as Technologist/R&D/ Management expert / industrial expert of National /International repute.

10. Experience

Candidate should be well conversant with the problems and prospects of the Iron & Steel Industry with special emphasis on the secondary steel sector.

Preference would be given to person having experience as Head of the Department / Division of an organization either in steel industry or any other metal industry. The person should have a track record of collaboration with different institutes / organizations of repute and have demonstrated leadership in promoting development and adoption of technology/innovation for continuous improvement.

11. Age

12. PERIOD OF APPOINTMENT
