I. COMPANY PROFILE

Steel Authority of India Limited (SAIL) was incorporated under the Indian Companies Act, 1956 with the objective to plan, promote and organize an integrated and efficient development of iron and steel and associated input industries. "The Public Sector Iron and Steel Companies (Restructuring and Miscellaneous Provisions) Act, 1978" was enacted with the aim to bring all the public sector integrated plants under the overall control of an integrated company i.e. SAIL which is to function as an integral steel complex. SAIL is a Schedule 'A' / Maharatna PSE in Steel sector with the administrative jurisdiction of Ministry of Steel.

The company employed 62181 regular employees (Executives 10504 & Non-Executives 51677 as on 31.3.2022.

The authorized and paid up capital of the Company was Rs. 5000 crores and Rs. 4130.53 crores respectively as on 31.03.2022.

Its Registered and Corporate offices are at New Delhi.

The shareholding of the Government of India in the company is 65% as on 31.03.2022.

II. JOB DESCRIPTION AND RESPONSIBILITIES

The Chairman is the Chief Executive of the Corporation and accountable to its Board of Directors and Government of India. He/She is responsible for the efficient functioning of the Corporation, and for achieving its corporate objectives and performance parameters.

III. ELIGIBILITY

The applicant should be Engineering graduate/ Chartered Accountant/ Cost Accountant/ Post Graduate/Graduate with MBA/ PGDIM from a leading Institute.

4. EXPERIENCE:

Applicants should possess cumulative experience/exposure of at least 5 years during the last 10 years in Business Leadership/ Finance/ Business Development/ Production/ Operations/ Marketing in a large organization of repute.

Exposure in Iron and Steel/ Metal Manufacturing/ Mining or related sector/ Project Management will be desirable.

Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

3. For candidates from SPSE/ Private Sector

- a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.
- b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.
- 4. In the above cases, no request for relaxation or otherwise would be entertained.
