





Detailed guidelines for Nominated Members of
Steel Consumers' Council

- (i) The duties/functions of nominated Members are as under:-
 - a) To advise and assist the Council on matters relating to supply of iron and steel to consumers in their area
 - b) To bring to the notice of the Council grievances of the consumers in their area
 - c) To suggest to the Council improvements in the local distribution system of the main producers.
- (ii) Normally, members shall bring or raise the aforesaid matters before the Council in its meetings. However, urgent issues / grievances of consumers requiring immediate attention may be brought to the notice of the Ministry.
- (iii) They shall not raise matters relating to staff discipline and appointment, financial accountability and day-to-day working of the steel companies both in the public and private sector or any other matters which are beyond the sphere of their functions mentioned above.
- (iv) To facilitate the occasional visits of members to the Ministry, entry passes may be issued by the Reception Officer on the basis of their I-Cards issued by the Ministry.
- (v) Steel is a de-regulated sector. Members are not expected to inspect or visit the plants or premises of public or private steel producers or dealers and give suggestions to them in their business matters.
- (vi) Ministry of Steel shall not provide any stationery such as letterheads, visiting cards etc. to them. If they desire, they may print their letterheads and visiting cards writing their names and residential or own official addresses, if any. They may write their designation as "**Member, Steel Consumers' Council of Ministry of Steel**" and should not print their address as Ministry of Steel, Udyog Bhawan, New Delhi.
- (vii) Members of the Council cannot use State Emblem on their letterheads, visiting cards, seats, crests, badges, house flags, vehicles or for any other purpose. Unauthorized or improper use of State Emblem is a punishable offence under "The Emblems and Names (Prevention of Improper Use) Act, 1950".

- (viii) Use of red light on vehicles is governed by the Central Motor Vehicles Rules, 1989. Nomination to the Council does not entitle the members of the Council to use red lights and/or placards on their cars/vehicles with or without State Emblem.
- (ix) Outstation Members invited for the meetings may be reimbursed AC II Tier / First Class train fair from the nearest station of their normal place of residence to the station of the meeting strictly on production of tickets. Members residing at the station of the meeting are not eligible to claim reimbursement even if they have given an alternative or permanent address of a place other than the venue of the meeting.
- (x) Free board, lodging and transport may be arranged for the Members during their stay for the meeting. If they prefer to stay in hotels of their choice instead of the hotels booked for them, they shall not be provided any reimbursement for the same.
- (xi) If any Member acts in violation of the aforesaid guidelines or his action is found to be detrimental to the interests of steel sector or he has been convicted by a Court of Law in criminal proceedings, his membership may be cancelled.
