GUIDELINES FOR CSR

312. DR. KIRODI LAL MEENA:

Will the Minister of Steel be pleased to state:

- (a) the guidelines for spending Corporate Social Responsibility (CSR) funds and the details thereof with regard to works and places for which it has been spent during last five years; and
- (b) the parliamentary constituencies in Rajasthan where CSR funds have been spent for community development, the parliamentary constituency-wise details thereof?

ANSWER

THE MINISTER OF STEEL

(SHRI DHARMENDRA PRADHAN)

(a) The Government provides the broad framework for Corporate Social Responsibility (CSR) through Section 135 of the Companies Act, 2013 (Act), Schedule VII of the Act and Companies (CSR Policy) Rules, 2014. Section 135 of the Act enumerates the provisions concerning CSR, Schedule VII of the Act indicates the eligible CSR activities to be undertaken by the Company and Companies (CSR Policy) Rules, 2014 prescribes the manner in which companies shall comply with CSR provisions of the Act.

Department of Public Enterprises has issued guidelines on 10.12.2018 to all administrative Ministries and Central Public Sector Enterprises (CPSEs) for adopting a theme based focused approach every year on CSR expenditure by CPSEs. These guidelines, inter-alia, provide that CPSEs exceeding the threshold limits as specified in the Companies Act, 2013 have to allocate at least 2% of their average net profits (PBT) of three immediately preceding years for CSR activities. CSR expenditure for such thematic programmes should be around 60% of annual CSR expenditure of CPSEs and the aspirational districts identified by NITI Aayog may be given preference.

Expenditure incurred on CSR by CPSEs under Ministry of Steel are broadly as per the thrust areas of the CSR activities laid down under Schedule VII of the Companies Act, 2013 and includes promotion of educational health, women empowerment, sustainable income generation through Self Help Groups, assistance to divyangs, access to water and sanitation facilities, village development, environment sustenance, sports coaching, promotion of traditional art and culture, etc. CSR projects are mainly carried out in periphery of steel plants, steel townships and mines.

A statement showing States/UTs where CSR has been undertaken and expenditure incurred by the CPSEs under Ministry of Steel during the last five years viz. 2015-16 to 2019-20, is given at **Annexure I.**

(b) NMDC Ltd. has spent Rs.15.81 lakh in District Jaipur in Rajasthan in the FY 2015-16 under CSR.
